ADOLESCENT IMMUNIZATIONS - COMBO 2

Assesses adolescents 13 years of age who have had the following by their 13th birthday:

- ✓ **1** dose of meningococcal vaccine *(given between their 10th and 13th birthday)*
- ✓ **1** Tdap vaccine *(given between their 11th and 13th birthday)*
- ✓ The **complete** human papillomavirus (HPV) *(given between their 9th and 13th birthday)*

CHILDHOOD IMMUNIZATIONS - COMBO 10

Assesses children 2 years of age who had the following by their 2nd birthday:

- ✓ **4** diphtheria, tetanus and acellular pertussis (DTaP)
- ✓ **3** polio (IPV)
- ✓ **1** measles, mumps and rubella (MMR)
- ✓ **3** haemophilus influenza type B (HiB)
- ✓ **3** hepatitis B (HepB)
- ✓ **1** chicken pox (VZV)
- ✓ **4** pneumococcal conjugate (PCV)
- ✓ **1** hepatitis A (HepA)
- ✓ **2-3** rotavirus (RV)
- ✓ **2** influenza (flu) vaccines

WELL-CHILD VISITS (15 MONTHS)

Assesses children who turned 15 months old during the measurement year and had six or more well-child visits with a primary care physician by the time they are 15 months old. These visits can occur when the child is within their first week of life, one month, two months, four months, six months, nine months, 12 months and 15 months.

No. The quality measure is not met because the sixth visit, at 15 months, was one day after the anchor date for the measure to be met.
