Nursing homes with five stars are considered to have higher than average quality and nursing homes with one star are considered to have quality much below average. **Please keep in mind that this is only a guide and cannot address all of the considerations that go into selecting the facility that is best for you.**

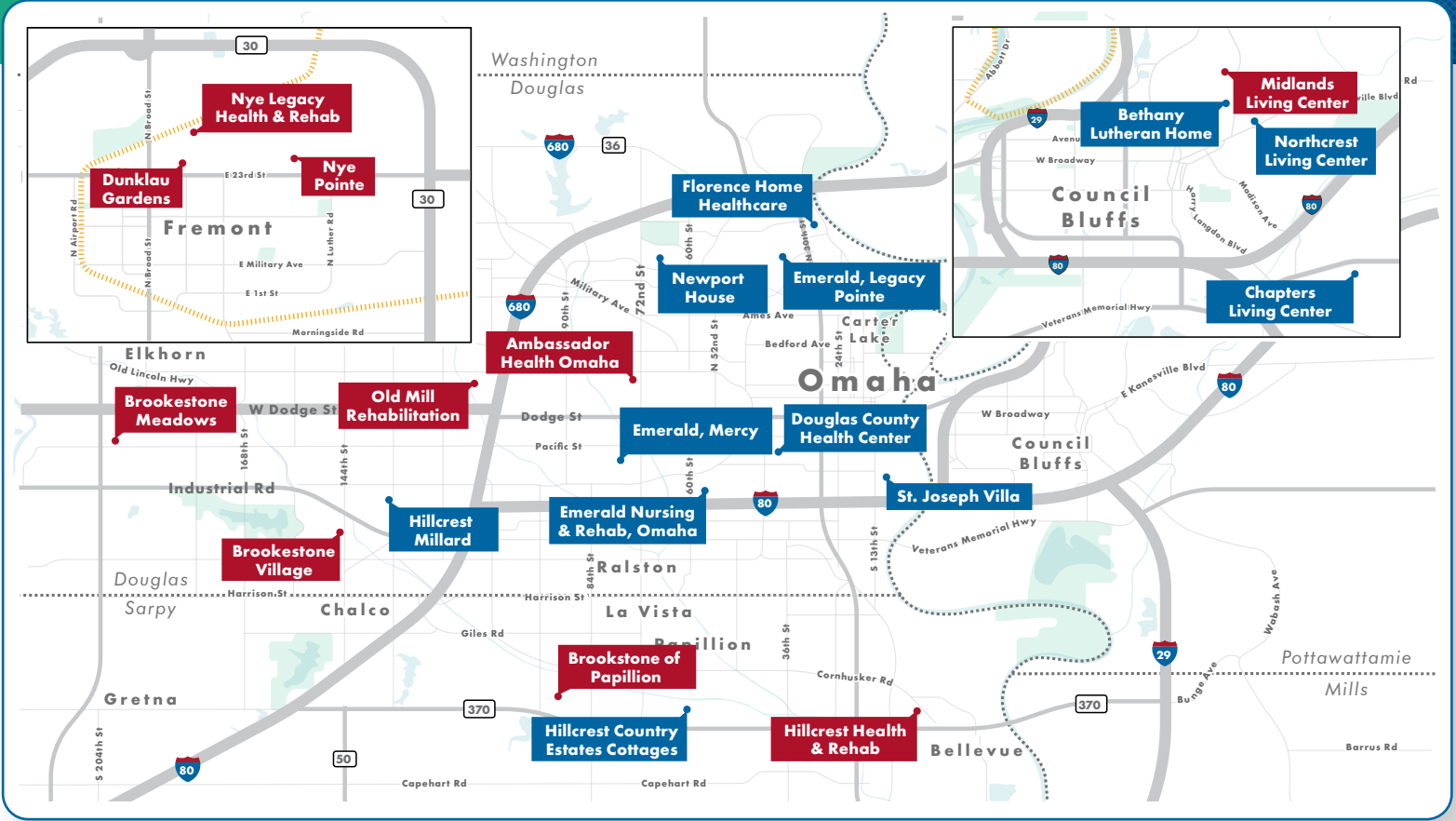

## What is the skilled nursing facility 3-day waiver rule?

Medicare beneficiaries have to stay in a hospital for 3 days in a row before Medicare will pay for their stay at a skilled nursing facility. This is called the skilled nursing facility 3-day rule. Some Accountable Care Organizations, like the Nebraska Health Network, are approved for a skilled nursing facility 3-day rule waiver and have partnered with skilled nursing facilities. This means you may be able to get skilled nursing and/or rehabilitative care in a skilled nursing facility without staying at a hospital first. Skilled Nursing Facilities eligible for the 3-day rule waiver are highlighted with a (●) below and in **red** on the map.
